

Notice to Students of Disclosures Required by Federal Law – 2016

Villanova University annually makes information and various statistics available to the University community, including information which is required to be disclosed by federal law. The following information is currently available either on the University's website at the links listed below, on the University's [Higher Education Act \(HEA\) Information web page](http://www1.villanova.edu/villanova/president/higheredact.html) (<http://www1.villanova.edu/villanova/president/higheredact.html>) or in hard copy. For those reports available online, the University will provide you with a hard copy upon request to the particular department.

1. A student who has been convicted of any offense under any Federal or State law involving the possession or sale of a controlled substance for conduct that occurred during a period of enrollment for which the student was receiving any grant, loan, or work assistance under federal law, shall not be eligible to receive any federal grant, loan, or work assistance during the period beginning on the date of such conviction and ending after the interval specified on the following table:

If convicted of an offense involving:

The possession of a controlled substance:

First offense
Second offense
Third offense

Aid ineligibility period is:

1 year
2 years
Indefinite

The sale of a controlled substance:

First offense
Second offense

2 years
Indefinite

A student whose eligibility has been suspended under the above paragraph may resume eligibility before the end of the ineligibility period determined under such paragraph if – (a) the student satisfactorily completes a drug rehabilitation program that – (i) complies with such criteria as prescribed by regulations, and (ii) includes two unannounced drug tests; (b) the student successfully passes two unannounced drug tests conducted by a drug rehabilitation program that complies with such criteria as prescribed by regulations; or (c) the conviction is reversed, set aside, or otherwise rendered nugatory.

For “willful” infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys’ fees. Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense.
