Special Presentation

• Matthew Harris, Office of Admissions (Erica Woods could not attend)

Matt Harris, VU Alum, BA (2006) MPA (2014), provided an update on admissions. VU hosted over 51,000 visitors for the class of 2029, for a goal of a class size of 1,770 (+50 from Class of 2028). Applications received were a record 26,300 from 6,000 high schools, 49 states, and 123 countries. The goal for the class of 2030 is 1,970 students (+200 across colleges).

A robust discussion ensued regarding the acceptance rate of qualified applicants, attrition rates, the status of test optional applications, international students, impacts of the "academic cliff" and current political climate, risks and benefits of a high applicant and low yield rates, and efforts to target economically disadvantaged students.

Rosemont College impact: Villanova's position is strong. The terms for transition date are fixed. There is a difference between acquisitions (Cabrini) vs. merger (Rosemont) with possibility for more liability for Rosemont, but small size of Rosemont suggests impact would be limited. Rosemont tenured faculty would have to apply for tenure again. Numbers are small with minimum impact at Villanova. There was no discussion of whether these faculty would take the positions promised in the Strategic Plan.

As was pointed out in the Middle States report, several elections were uncontested, which was interpreted as a lack of faculty interest. It is important for faculty governance for these seats to be contested elections so please nominate qualified individuals to run for these six seats.

FRRC continues to address issues raised by faculty and administration regarding the policies and procedures related to the Faculty Handbook. Current work includes:

- 1. Third year review process: Updates are finalized and will be reflected in the R&T Policy.
- 2. Evaluation of Deans: Next stage of revisions are being discussed at the April FRRC meeting.
- 3. CNT promotion policies: Clarifying procedures including term limits for University committees and consistency with other procedures is ongoing.
- 4. Emeritus promotion: Angela DiBenedetto & Christopher Kilby are leading this process.
- 5. Teaching loads: Updating the description to reflect the strategic plan.

We are being attentive to the concerns raised by the national climate and will be monitoring how faculty are affected by decisions. As always, please bring any concerns related to faculty rights to Michelle Kelly or any member of FRRC.

Appendix B: Committees with Faculty Representation

1. Academic Policy Committee

At the March meeting of the APC, the committee heard a report from the Subcommittee on the Personal Day excused absence policy, and the chair of the APC re-introduced a proposed change to the Attendance Policy for first-year students. Working on the assumption that it is too soon to adequately assess the impact of the Personal Day excused absence policy, the subcommittee proposed minor revisions that would ease restrictions on when it could be used (for instance, the excused absence might be used twice in the same week, for a 3-day a week course). However, the new excused absence has only exacerbated long-standing challenges to attendance in courses for first-year students. This new excused absence coupled with the post-Covid practice of encouraging students to engage in self-care of minor illnesses, has created a real mess for those faculty trying to adhere to the stipulated attendance policy for first-year students. A key element of the proposed revision to the Attendance Policy, along with the elimination of the specific policy for first-year students, is an additional sentence in the second paragraph indicating that it is the student's responsibility to adhere to the attendance policy of each course and that "some colleges, department, and programs" may have their own attendance policies. 2. Athletic Advisory Committee

I have scheduled a series of meetings with key stakeholders. On March 6, I met with Prof. Jeremy Kees, our official NCAA faculty athletics representative., On March 26, I am meeting with the new athletics director (and VP) Eric Roedl. I am awaiting scheduling of a meeting with Jenn Brophy, the director of academic support for athletics. I have also emailed Katie LeGrand, the associate AD in charge of compliance, and am awaiting a response. It is a time of momentous changes in college sports due to NIL and the pending *House* settlement, so I look forward to thinking carefully with all the stakeholders about what this means for everyone going forward. I anticipate having more to say after I've had these meetings.

4. Mission and Social Justice Committee

The Mission and Social Justice Committee discussed the letter the Villanova Student Government Association sent out in early March encouraging the student body and the general Villanova community to embrace the university's Augustinian values.

As a committee, we continue to offer recommendations to the president for continued communication with the student, staff, and faculty members during this stressful time. We are grateful for Father Peter taking the time to listen to the faculty, but staff and students feel they should have similar dialog sessions. Perhaps the Office of Mission and Ministry could host these sessions, so leadership is not at risk of making public statements that could be misconstrued. The

committee is asking the office of the president if any additional information can be shared with the Villanova community, even if the message is, "We continue to monitor the situation."
