4. Tax exempt interest	List the amount of tax exempt interest from your 2022 IRS Federal 1040 Line 2a		
5. Untaxed portions of IRA distributions and pensions	Refer to your 2022 IRS Federal Income Tax Return (1040), (Lines 4a + 5a) minus (Lines 4b + 5b). Exclude Rollovers
