## Notice to Law Students of Disclosures Required by Federal Law – 2023

This notice is being provided to you as required by the Higher Education Act and its various amendments. Villanova University annually makes information and various statistics available to the University community, including information which is required to be disclosed by federal law. For those reports available online, the University will provide you with a hard copy upon request to the particular department.

1. Villanova University's Student Records Policy is published annually in the Charles Widger School of Law <u>Student Handbook</u>. The Handbook explains the rights of students and University procedures with respect to educational records under the Family Educational Rights and Privacy Act.

4. Villanova University's Department of Athletics' annual report under the Equity in Athletics Disclosure Act provides data on the University's intercollegiate athletic programs. 5. Information concerning special facilities and services available to students with disabilities is available through the Office of Academic Success Programs, (610) 519-7136 or the Student Affairs Office, (610) 519-5228. The information is listed on the website under <u>Academic Accommodations</u>.

6. Students are reminded that the unauthorized distribution of copyrighted material, such as through peer-to-peer networks, is illegal and violates University policy. Information concerning unauthorized peer-to-peer file sharing is available in the Copyright Infringement and Illegal File Sharing Policy. Copyright Infringement is the act of exercising, without permission or legal authority, one or more of the exclusive rights granted to the copyright owner under section 106 of the Copyright Act (Title 17 of the United States Code). These rights include the right to reproduce or distribute a copyrighted work. In the file-sharing context, downloading or uploading substantial parts of a copyrighted work without authority constitutes infringement. Penalties for copyright infringement include civil and criminal penalties. In general, anyone found liable for civil copyright infringement may be ordered to pay either actual damages or "statutory" damages affixed at not less than \$750 and not more than \$30,000 per work infringed. For "willful" infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys' fees. For details, see Title 17, United States Code, Sections 504, 505. Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense.
