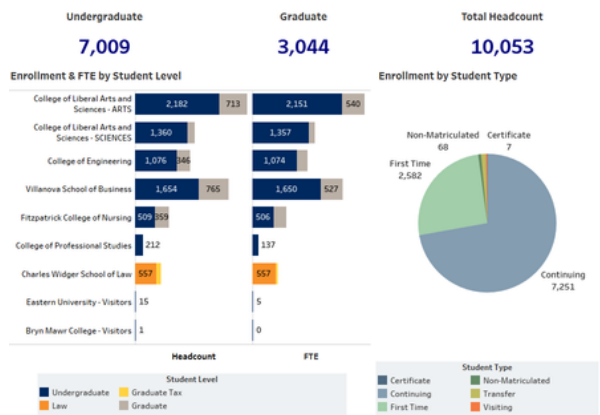

Stay up to date with key deadlines for ensuring the accuracy and timeliness of report submissions. Below are essential census data freeze and survey submission dates to keep in mind for various reporting areas.

Fall Census Data Freeze Dates:

- Degree Completions: August 1, 2024
- Student Admissions & Enrollment: September 17, 2024
- Student Financial Aid: November 20, 2024
- Staff and Faculty: October 21, 2024

Fall Survey Submission:

- IPEDS Surveys – Completions and 12-month Enrollment: October 16, 2024
- *US News & World Report* Online Program Surveys (CPS, COE, VSB): October 21, 2024
- Other Submissions – Dates Vary
 - S&P, Moody's (enrollment data)
 - AACSB (VSB), AACN and NLN (FCN)
 - Common Data Set

Data Governance

Current Initiatives in Progress:

- **Data Classification Matrix and Data Retention Policy** – Department meetings across campus will continue though the fall to classify data elements in each area as well as review current/future retention periods.
- **Data Definitions/Dictionary** – We are working with UNIT to evaluate tools and identify/leverage the knowledge of data around campus.
- **Data Stewards Best Practices** – Admission/Student groups using Slate met to share data challenges and solutions. Future discussions will expand on data integrity.
- **External Survey Reporting Guidelines** – Please refer to these when reporting data externally.

Current Higher Ed Topics

- **Federal Financial Value Transparency and Gainful Employment Reporting (FVT/GE)**: Higher education institutions are required to report information on graduates' earnings, debt levels, and employment outcomes to measure the financial value of their educational programs. An interdepartmental effort is underway to ensure Villanova's submission is validated and submitted in a timely manner. The due date is January 15. [See here for more information.](#)
- **IPEDS Race/Ethnicity Definition Changing**: The federal government has updated its race and ethnicity definitions. Middle Eastern or North African (MENA) will have its own reporting category and data on race and ethnicity are now combined into one question, rather than asking about Hispanic or Latino ethnicity separate from race. Higher education institutions will have to comply with these changes by March of 2029, if not sooner. [See here for more information.](#)

Data Request Protocol: When submitting a data request, please clearly state:

- The purpose of your request.
- Detailed information about the data you need.
- Anticipated timeline to ensure timely delivery.
- If applicable, provide the name of the external agency with whom you intend to share this data.
