

### **Data Governance**

#### **Current Initiatives:**

- Data Classification Matrix and Data Retention Policy –
  Work has been ongoing in a comprehensive process to
  identify and classify each department's data requiring
  multiple touchpoints. ODSDI is working in close
  collaboration with the Office of Information Security and
  have produced data classifications with 25 departments
  so far and the remaining departments will be contacted
  in 2026.
- Data Literacy Small-group trainings for Data Insights users, plus dashboard data definitions to support data access, visualization, and decision-making.

## **Mandatory Reporting Update**

On October 1, 2025, we submitted the **Federal Financial Value Transparency and Gainful Employment (FVT/GE)** report for the 2024–2025 aid year. This complex, federally required report integrates multiple data sources to ensure transparency around higher education program costs, student debt, and postgraduation earnings.

This year's submission was made possible through the collaboration of five key offices—Registrar, Bursar, Financial Aid (Main and Law School), OSPIE, and ODSDI. We thank all involved for their precision, dedication, and teamwork in meeting these rigorous reporting requirements.

We are also in the process of submitting the IPEDS, US News & World Report and accreditation-related surveys that are due this fall.
