# Investing in Future Villanovans



### Leslie Book, JD, LLM

John H. Buhsmer Esq. '84 Endowed Professor of Law

A national authority on tax procedure and tax administration, Leslie Book is the successor author for the Thomson Reuters treatise IRS Practice and Procedure and the cofounder and one of the primary bloggers at Procedurally Taxing. At Villanova, he has served as director of the Federal Tax Clinic, Graduate Tax Program and Online Graduate Tax Program, and a professor in residence with the IRS Taxpayer Advocate Service. Book was appointed the inaugural John H. Buhsmer Esq. '84 Endowed Professor of Law in 2024. He received the Law School's inaugural Diane Ambler Award for faculty curricular innovation in 2018 for creating the Online Graduate Tax Program

with Professor Joy Mullane. In 2021, he won the Diane Ambler Faculty Scholarship Impact Award, which recognizes work that has substantially impacted the law, the academy, the legal profession or policy debate. Book received his BA from Franklin & Marshall College, his JD from Stanford University School of Law, and his LLM from New York University School of Law.



Michelle Madden Dempsey, JD, LLM, PhD

Harold Reuschlein Scholar Chair

Michelle Madden Dempsey is a widely published scholar in the philosophy of law and recognized expert on legal matters related to gender-based and sexual violence. A former prosecutor and civil litigator, she came to Villanova Law in 2009, where she specializes in criminal law, feminist theory, and legal philosophy. In 2014, Dempsey co-founded the law school's Institute to Address Commercial Sexual Exploitation. She previously served as the law school's Associate Dean for Faculty Research and Development and was appointed the inaugural Harold Reuschlein Scholar Chair in 2018. She received the

Villanova Law Student Bar Association Faculty Member of the Year Award in 2019 and 2021 and is also the 2022 recipient of the Diane Ambler Scholarship Impact Award. She earned her JD from the University of Michigan, her LLM from the London School of Economics, and her doctorate (DPhil/PhD) from the University of Oxford. Before joining Villanova Law, Dempsey taught criminal law and jurisprudence at the University of Oxford.
