We are welcoming our Class of 2020 to campus next Wed., Aug 16 where we will kick off a three-day orientation.

We are delighted to be welcoming two new permanent faculty members to the Law School:

- Brett Frischmann is joining us as the Charles Widger Endowed University Professor in Law, Business, and Economics. Brett will be teaching Internet Law in the Fall 2017 semester and two new Law, Economics, & Technology courses (pending faculty approval) in the Spring 2018 semester.
- Josephine Sandler Nelson is joining us as an Associate Professor of Law. Josephine will be teaching Corporate & White Collar Crime in the Fall 2017 semester and Business Ethics and Business Organizations in the Spring 2018 semester.

We also are welcoming back Michael Moreland as the University Professor of Law and Religion. Michael will be teaching Constitutional Law II in the Fall 2017 semester and Law & Religion Seminar in the Spring 2018 semester. He also will serve as Director of the Eleanor H. McCullen Center for Law, Religion and Public Policy.

Four new Visiting Assistant Professors will be joining us for the 2017-2018 year:

- Marissa Bostick will be teaching Criminal Law in the Fall 2017 semester and Advanced Issues in Criminal Law Seminar in the Spring 2018 semester. Marissa has a B.A. from Penn and her J.D. from Columbia. She has worked as an associate at O'Melveny & Myers LLP and as an Assistant U.S. Attorney in the Southern District of New York.

- Keri Clapp will be teaching two sections of Legal Writing I in the Fall 2017 semester and two sections of Legal Writing II in the Spring 2018 semester. Keri earned her B.S. from Bowling Green State University and her J.D. from Penn. She has worked as an associate at Drinker Biddle & Reath and as a staff attorney for the Postal Service, and has taught legal writing as an adjunct professor at Widener Delaware.
- Orli Oren-Kolbinger will be teaching the Tax Policy Seminar in the Fall 2017 semester and Empirical Analysis of Law in the Spring 2018 semester. Orli earned her B.A., LL.B., and LL.M. from the University of Haifa and is a Ph.D. candidate in Law at Bar-Ilan University. She has served as a Military Prosecutor in the Israeli Defense Forces. Orli joins us from the University of Michigan Law School, where she was a Michigan Grotius Research Scholar. Orli's position is funded as part of our grant from the Charles Koch Foundation.
- Jillian Schroeder-Fenlon will be teaching Legal Writing I and Legal Writing III (Transactional) in the Fall 2017 semester and Legal Writing II and Legal Writing III (Transactional) in the Spring 2018 semester. Move in and New Student Orientation

- In support of Move in and New Student Orientation it will be necessary to limit parking and block off certain areas to stage the move in. We appreciate everyone's patience and understanding during this high volume time.
- Starting on Thursday Aug. 17, I-1 Garage will be exit only as of 5 p.m. and will remain closed on Friday, Aug. 18. Starting at 10 p.m. Thursday, Aug. 17, I-2 will be exit only.
- Friday, Aug. 18, the University is expecting high volumes of traffic for move in from the hours of 8 a.m.-6 p.m. All are encouraged to avoid Lancaster and S. Ithan Avenues.
- Persons who normally park in the I-1 Garage and M-1 Garage are being asked to park in the A-2, S-4 Garage, or M-2 Garage. M-2 Garage will be limited in parking to the lower level. L-2 hang tags will be asked to park in the Farrell Hall/Stone Hall area or overflow to the S-2 lot. Students may park on W-2 and S-4 Garage during this time period. Officers working on campus may direct you to other areas open for parking on all of the affected dates.
